Town Hall Projects Update

Since our formation over eight years ago, the staff and volunteers of the Town Hall Coalition have advocated to protect Sonoma County forests, wildlands, rural community rights, and the common good. We have assisted with the formation and support of independent grassroots neighborhood groups throughout the county. We follow important issues before the Board of Supervisors and other decision making bodies. We analyze policy, comment, and provide you with alerts because we know that people are busy and do not have time to attend Board meetings and follow each development. Forest Conversion Ordinance

Sonoma County's remaining redwood forests are threatened by encroaching development and conversion to vineyards. Town Hall Coalition has been working since 1998 to pass a County Ordinance regulating Forest Conversion. On February 7, 2006, the Sonoma County Board of Supervisors voted 4-1 for a Timber Conversion Ordinance which gives the County guidelines to begin regulating conversions of our precious forests for the first time. But the problem of "Chainsaw Wine" is still a threat. Stay tuned!



General Plan Update



Town Hall Coalition joined Coastal Forest Alliance and others to protest "Chainsaw Wine"- deforestation for vineyards at the **Board of Supervisors on August 23, 2005.**

Town Hall Coalition will be submitting comments as Sonoma County updates its General Plan in 2006. This is an opportunity to protect our rural neighborhoods from wine factory invasions. We are in the process of commenting on the General Plan update which allows placement of "agricultural" support services including wine bottling factories; event, wedding, and concert halls; parking lots; commercial kitchens; roadside wine bars, campgrounds, bed and breakfasts, tourist souvenir shops and other commercial and industrial uses sprawled throughout diversified ag land and other rural areas of the county.

Formation of Neighborhood Groups-Save Our Sonoma County (SOS)

Town Hall Coalition has organized a network of grassroots neighborhood groups in rural areas throughout Sonoma County who are threatened by the development of wine factories and related uses where there is no infrastructure. These wine factories threaten water, public health, and safety of the residents in these neighborhoods. Wine factories belong in areas that are zoned for industry with infrastructure such as sewer, water, and roads. Contact the Town Hall office for more information.
